

Chicago State University (CSU) is a comprehensive, urban university that serves the greater Chicago metropolitan area. The primary purpose of the university is instructional; it offers 36 undergraduate and 22 graduate programs, including a doctoral program in educational leadership. There are six colleges that comprise the university: Arts and Sciences, Business, Education, Health Sciences, Pharmacy, Honors College, and the Division of Continuing Education, which provides talented students with unique learning opportunities.

Founded in 1895, Eastern Illinois University (EIU) is located in Charleston, 180 miles south of Chicago, 140 miles northeast of St. Louis, and 9 miles east of I-57. Amtrak has daily train service to this area. Colleges within the university include: Business and Applied Sciences; Sciences; Education and Professional Studies; and Arts and Humanities. The Honors Program is available to students who meet the following criteria; (1) Upper 10% of the high school graduating class or a 3.5 cumulative GPA on a 4.0 scale and (2) ACT composite of 26 or above. Participants in the Honors Program may receive limited onetime as well as renewable scholarships. Presidential scholarships are available to Honors students who (1) top 10% of graduating class or a 3.5 cumulative GPA and (2) 30 ACT or (1) top 5% of graduating class or a 3.75 cumulative GPA and (2) 28 ACT. Talented Students Awards are also given in fine arts, athletics and journalism.

Admissions Requirements Freshmen

Applicants will be considered for admission based on high school college preparatory coursework*, cumulative grade point average, grade trends, class rank, ACT or SAT score, personal statement and in some cases, academic letters of recommendation.

*High school college preparatory coursework of:

Four years of English

Three years of mathematics including algebra 1, geometry, algebra 2 -trigonometry or higher

Three years of science with laboratory experience

Three years of social science with one year of United States history/government

Two years of electives (academic or vocational)

+Two years of foreign language

+Foreign language is not an entrance requirement; however, Eastern does require one year in a single foreign language for graduation. Students with two years of a single foreign language in high school with a "C" average will be considered to have met this requirement.

GPA of 2.5/4.0 with 24 or more hours. GPA of 2.0/4.0 with 30 or more semester hours. GPA of 2.0/4.0 at most recent school of attendance. Students with less than above semester hours must also meet freshman criteria.

Governors State University (GSU) offers majors and courses to juniors, seniors, and graduate level students only. It is the only public upperdivision university in Illinois founded to serve the needs of community college graduates, transfer students, and other returning adult and commuting students who have the equivalent of two or more years of college. High school students who are considering attending a community college can follow a "2-step" approach to earning a bachelor's degree by (1) obtaining an associate's degree or completing 60 semester or 90 quarter hours at their local community college and then (2) transferring to GSU to obtain a bachelor's degree. GSU and several community colleges in Illinois have developed articulation agreements and transfer guides that enable students to make a smooth transfer and transition from the community colleges to upper-division majors at GSU. GSU offers 21 undergraduate majors, 12 concentrations, and 17 minors in the liberal arts, sciences, education, business, health professions.

Admissions Requirements

Freshmen

As GSU enrolls only juniors, seniors, and graduate students, it is inappropriate for GSU to establish minimum high school course requirements for baccalaureate program admission as established by the Illinois Board of Higher Education.

Transfers

A minimum of 60 semester or 90 quarter hours with a minimum GPA of 2.0 or an AA or AS degree from a regionally accredited institution and good standing at the last institution attended are required. Students not meeting the above criteria may petition for admission under certain circumstances. Specific majors have established selective criteria above the university minimum. Refer to the Governors State University Catalog for specific major criteria. Specific deadline dates for the fall, winter and spring-summer trimesters are published in the schedule of classes for each trimester and the GSU Catalog.

Founded in 1857, Illinois State University was the first public university in the state and is one of the Midwest's oldest institutions of higher education. It is a coeducational, residential university whose emphasis is on undergraduate study. Its 34 academic departments in six colleges offer 165 majors. The University is in the twin-city community of Bloomington-Normal near the geographic center of the state, 137 miles southwest of Chicago and 164 miles northeast of St. Louis.

- In making admission decisions, Illinois State considers the following:
- Rigor of courses completed and grade trends
- · Grade point average
- ACT/SAT scores (writing exam not required)
- · Academic personal statement (approximately 500 words) addressing:
- Why Illinois State is a good fit for student's educational goals.
- Identify and explain academic strengths and weaknesses.
- Explain circumstances which affected student's high school academic performance.

Applicants must also show successful completion of the following:

- English 4 years
- Mathematics 3 years (Algebra, Geometry, Algebra II)
- Natural Science 2 years with laboratories
- · Social Science 2 years
- Foreign language/Fine arts 2 years of one foreign language or 2 years of fine arts
- Electives 2 years

Of the freshman admitted for the 2009-2010 academic year, half earned ACT composite scores of 23-27. A quarter of the admitted students scored 28 or above, and another quarter scored between 18 and 22. The average high school grade point average of freshmen admitted was 3.5/4.0.

Transfers

Illinois State considers the following in making admission decisions:

- Cumulative college grade point average
- · Prerequisite college coursework for some programs
- Applicants must be in good academic standing at the last institution attended
- Applicants must be able to show proof of high school graduation or passing score on GED exam.

If students meet the class rank or ACT/SAT requirement but are deficient in any of the subject areas, they may still be eligible for admissions.

Must have an overall GPA of 2.0 and good standing at the last college attended fulltime.

Students with fewer than 24 semester hours must also meet freshman admissions requirements.

Application Deadlines:

Completed application, high school transcript and ACT/SAT score for fall 2011 must be on file in the Admissions Office by July 1, 2011.

Tuition and Fees (2010-11 Annual)

Tuition is guaranteed for four consecutive years for newly enrolled undergraduate students seeking their first bachelor's degree. Students enrolled for the fall 2010 term, will pay the same rate of tuition through the summer of 2014. The Tuition Guarantee Plan applies only to tuition. Fees may increase during the four years.

Admission Requirements Freshmen (minimum criteria for admission consideration)

Graduation from a secondary school. High school class rank 50-99th percentile (or 2.75 grade point average on a 4.0 scale) and ACT of 19 or SAT 870 (CR+M). High school class rank 34-49th percentile (or 2.5 grade point average on a 4.0 scale) and ACT of 23 or SAT of 1030 (CR+M).

New ACT/SAT Writing Tests

Although NIU welcomes the addition of the writing tests introduced by both ACT and SAT, NIU will recommend but not require the ACT writing test, and will consider only the SAT critical reading and mathematics scores (CR+M) for admission consideration until the predictive value of the writing tests is determined.

Fall Semester 2011

Freshman Application Review

1. Individuals who submit complete applications including all transcripts and test score information by November 15, 2010 and who satisfy minimum admission criteria will be considered for admissions on a competitive basis and notified of the admission decision on or before February 1, 2011.

2. Individuals who submit complete applications after November 15 and satisfy minimum admissions criteria will be considered for admission on a competitive basis as long as space is available.

Priority application consideration for Fall Semester 2011

Priority consideration will be given to individuals whose applications

are complete by February 1, 2011, who rank in the upper third of their high school class and have an ACT composite score of at least 21 or SAT score (CR+M) of at least 950 or an equivalent ACT/SAT rank combination. These individuals will be admitted and notified of their admission decision on a rolling admission basis.

Personal Statement

A personal statement is strongly recommended only for students who do not satisfy the priority consideration parameters. The statement should focus on areas such as leadership experiences, expected contributions to the NIU community, and any personal experiences in overcoming adversity.

Weighted and un-weighted class rank and weighted and unweighted grade point average on a traditional 4.0 scale will be considered.

Admission is based primarily on high school rank, ACT composite score and course subject pattern. In addition to these criteria, student's files are reviewed for ACT subscores, high school grade point average, improvements in high school GPA from year to year, letters of recommendation, participation in service or extracurricular activities and extenuating circumstances.

High school subject pattern requirements: 4 years of English; 3 years of math including Algebra I, proof based geometry, and Algebra II; 3 years of laboratory science; 3 years of social science; and 2 years of electives. Students must meet the course pattern requirements described above for unconditional admission.

Transfers

With 26 semester hours or more, students must have a 2.0 or better (4.0 scale) as calculated by SIUC for all college work and must be in a good standing at last college attended. Students who have completed less than 26 semester hours, must also submit high school transcript and ACT scores and meet freshmen admission requirements in addition to transfer requirements. All first-time freshmen seeking admission to the University are required to complete the following high school course requirements: 4 years of English; 3 years of mathematics; 3 years of laboratory science; 3 years of social studies; and 2 years of electives. Applicants who do not meet the minimum high school course requirements are required to correct high school deficiencies as determined by the Office of Admissions.

Deadline for Fall 2011 Freshmen Admission

Applicants can apply beginning June 1 prior to their senior year with admission decisions beginning on September 15 and continuing on a rolling admission. SIUE does not require the ACT writing test and will consider only the SAT critical reading and mathematics scores for admission consideration. The University of Illinois at Springfield is one of three campuses of the University of Illinois. Today, the more than 4,500 students enrolled are a mix of traditional residential students and full- and part-time non-traditional students - those who have transferred to UIS from other institutions; returned to finish a degree; or who are seeking advanced degrees, second degrees, or professional programs. In October 1999, UIS reached a milestone in its history when the Illinois Board of Higher Education unanimously approved the campus' four -year baccalaureate program, Capital Scholars. Freshmen

Students should apply early. Recommended application deadline is May 15 for Fall semester and December 1 for Spring semester.

Regular admission:

Students must have an ACT composite of 20 or higher (SAT 940) and a high school cumulative grade point average of at least 2.5 (4.0=A). The higher the ACT is from a 20, the lower the GPA can be and vice versa. Class rank is not considered.

Alternative admission:

To be considered, students must have at least an ACT composite of 16 or higher (SAT 750) and a high school cumulative GPA of at least 2.2 (4.0=A). Applicants should submit a letter of appeal and two letters of recommendation.

High School Subject Pattern Requirements:

English, 4 units; social studies, 3 units; math, 3 units; lab science, 3 units; electives, 2 units including courses in art, foreign language, music, speech, journalism, film, religion, philosophy, theatre, vocational education or an additional year of math, science, or social science.

 Applicants to WIU-Macomb who have earned 24 or more semester hours (36 quarter hours) of college work and applicants to WIU-QC who have earned 60 or more semester hours (90 quarter hours) of college work must have at least a combined "C" average for all hours

standing at the last college/university attended.

- Applicants to WIU-Macomb who have earned fewer than 24 semester hours must meet freshman admission standards, have at least a combined "C" average for all hours attempted from all institutions, and be in good standing at the last college/university attended.
