As a result of Public Act 102-0475 (HB 3438), public institutions of higher education in Illinois are required to designate a person as an undocumented student liaison to assist both undocumented and mixed status students on their campuses. Northern Illinois University (NIU) dedicated an office with this charge in 2018 due to the mobilization and advocacy of the undocumented students of DREAM Action NIU. In 2022, the office became the first Undocumented Resource Student Center (USRC) in the state. The USRC is a physical space that offers wraparound services, such as inviting scholars and artists to speak about the experiences of undocumented individuals, mental health wellbeing support, scholarship workshops, and UndocuJoy events so our students can thrive and not just survive. The USRC also addresses exclusionary institutional polices and advocates at both the state and federal levels for our undocumented Huskies. This presentation shares best practices and lessons learned while honoring and centering undocumented students and those directly affected in all that we do.

ISACorps members have assisted qualifying undocumented students in applying for the state's Monetary Award Program (MAP) through the Alternative Application for Illinois Financial Aid, since it became available in January 2020; however, confusion often arises as to who should fill out the Alternative App versus the FAFSA, especially with blended status families. During this session, individuals will get an overview of the Alternative Application, learn about the differences between the Alternative App & the FAFSA, hear what mistakes we see families make, and how to be proactive with families to successfully submit the Alternative Application or the FAFSA.
