# Considering IACAC's mission and our work with transitioning students from secondary schools to postsecondary options, what do you hope to achieve within this role?

# Considering IACAC's mission and our work with transitioning students from secondary schools to postsecondary options, what do you hope to achieve within this role?

I am honored to be a candidate for Delegate Director; I value the possibility of joining the IACAC Executive Board and advocating for the best interest of students in the postsecondary planning process. I would utilize the role of Delegate Director as an opportunity to learn about issues facing our profession, educating other counseling professionals about these issues, and working with IACAC to enact change that promotes ethical practices and benefits the students we serve. The mental health of high school students is a topic widely discussed in secondary education. Anxiety and depression are on the rise amongst adolescents for many reasons. I think it is important to look at ways that we as counseling professionals can ease the anxiety associated with the college admissions/postsecondary planning process. This will require analyzing many of the other issues on the forefront of our profession: application deadlines, standardized testing, and the rising cost of college education, for example. All issues must be examined through a lens seeking equity and access for all students, and IACAC must continue to find ways to support students no matter their socioeconomic background, race, ethnicity, culture, gender, sexual orientation, or citizenship status.

IACAC is an organization of professionals serving students and families as they navigate the college admissions process; our greatest impact comes in our ability to consistently improve educational opportunities as they relate to our work. When I invest in an IACAC membership, the students on my caseload benefit indirectly. The focus on professional growth is, and should continue to be, the greatest impact our organization will make to its members. We are in a new age of technological tools like Facetime and Google Hangout that can be leveraged to connect with colleagues in different zip codes to share ideas. These examples are not just voices on the other end of a conference call, they allow for human connections through video and real-time interactions that webinars cannot provide. I believe this type of technology can increase value for our members and allow for more diverse participation in our programs.

#### Considering IACAC's mission and our work with transitioning students from secondary schools to postsecondary options, what do you hope to achieve within this role?

I hope to continue to serve as a student advocate in this complicated process as well as an advocate for my colleagues. High school counselors, especially those of us in public schools serving students most in need, are underrepresented in IACAC and in NACAC. This role will afford me the opportunity to speak up and advocate on behalf of my colleagues who do not have the opportunity to attend an annual conference. Many of us, especially those outside of the Chicago area, struggle to convince administrators of the importance of the work IACAC does on behalf of students. These professional school counselors simply cannot leave the building because the work we do serving students is the most important thing we do. In many cases, attending a conference in Bloomington or Louisville, Minneapolis or Itasca, is either not feasible or not encouraged.

As a Delegate Director, I will use my position to give voice to Illinois counselors. I will represent my colleagues on the Executive Board and in the NACAC Assembly. I will faithfully represent the interests of IACAC and of Illinois students. I know it sounds a bit idealistic, but in this position, I hope to influence NACAC and IACAC to continue putting the students we serve first.

#### If elected, what experiences, skills, and qualities do you bring to this specific position?

I believe that everyone, especially young adults, has the ability and the right to make decisions that impact one's own future. This core value to respect autonomous decision-making guides my practice as a school counselor, and not just in the postsecondary planning realm. As a Cochair of the Government Relations Committee, I had the opportunity to practice this principle in the political arena.

After years of building IACAC's reputation among legislators in the Illinois General Assembly as a trusted advocacy organization, the Government Relations Committee took a big step while I served as co-chair. Over the course of two years, my colleagues and I cultivated relationships with targeted legislators and other decision-makers in Illinois government. While the politicians waffled and failed to pass a budget, we quietly passed legislation that changed Illinois law to protect student ownership of test scores. This type of advocacy work is not for everyone, but I really enjoy it. I feel just as comfortable lobbying decision-makers in the halls of power as I do listening to first-generation college students and families at school.

The NACAC Assembly functions like a legislative body, and my experience working with the Illinois General Assembly makes me uniquely qualified to serve our Association and our students as Delegate Director.

#### Considering IACAC's mission and our work with transitioning students from secondary schools to postsecondary options, what do you hope to achieve within this role?

With all the changes in timelines, and in particular to the financial aid timeline, our students are increasingly stressed during the transition process. By working together, we can establish practices that coordinate the postsecondary and secondary school requirements such that the process is simple and clear for students and their families. We can also ensure those guidelines have enough flexibility for our postsecondary institutions to ethically craft individualized practices to identify candidates that will excel and persist at our institutions and contribute to the overall vision of our organization. The two are not mutually exclusive.
