Though this is just one of many initiatives to make higher education more accessible, there are many other ways to support and contribute. The time is now to fight for a better tomorrow! We look forward to engaging with everyone in this pivotal moment in history.

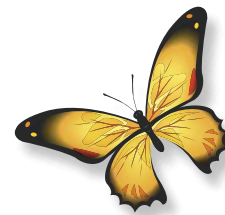
